Attention of the Trade is invited to Notification No. 01/2015 CE (NT) dated 20.01.2015 wherein, a change has been brought about in the jurisdiction of the following Commissionerates:-

- i. O/o. the Principal Commissioner of Central Excise, Bangalore I Commissionerate
- ii. O/o. the Commissioner of Central Excise, Bangalore II Commissionerate
- iii. O/o. the Commissioner of Central Excise, Bangalore III Commissionerate
- iv. O/o. the Commissioner of Central Excise, Bangalore IV Commissionerate.
- v. O/o. the Commissioner of Central Excise, Bangalore V Commissionerate.

The jurisdiction of the Commissionerates, Divisions and Ranges has been formed based on the jurisdiction of the re-organised BBMP Wards communicated vide Notification No. UDD 59 MLR 2009, Bangalore, dated 15.07.2009 issued by Urban Development Department, Government of Karnataka, in terms of Karnataka Municipal Corporations Act, 1976 and the peripheral Taluks and Districts.

3. The new jurisdictions of the Commissionerates, Divisions and Ranges with effect from 20.01.2015 have been defined and are as per the schedule annexed hereto.
4. The assesseees are requested to visit the Departmental website www.centralexcisebangalore.kar.nic.in to know about the new jurisdiction and for any difficulty the assessee are requested to contact the PROs of the respective Commissionerate.
5. All the Trade Associations and Chambers of Commerce and Industry are requested to bring the contents of this Trade Notice to the knowledge of their constituent members in general and Central Excise assesseees.
6. After 20.01.2015 and till the process of migration to new CDR is completed, assesseees would continue to pay duty using their existing CDR code (Commissionerate, Division and Range Code). It is also advised that all assesseees may mandatorily mention the Central Excise Registration No. in all their correspondences.
7. This Trade notice supersedes all other Trade Notices issued in this regard till date.
